 - c. Latest Residential Address Proof e.g. electricity bill.
 - d. Business Registration Certificate and the latest Profit Tax Demand Note, if the applicant is the sole proprietor of, or a partner in, a business.
 - e. Other asset proof e.g. Fixed Deposit Advice, Mortgage Loan Statement/Repayment Slip, Credit Card Statement.
