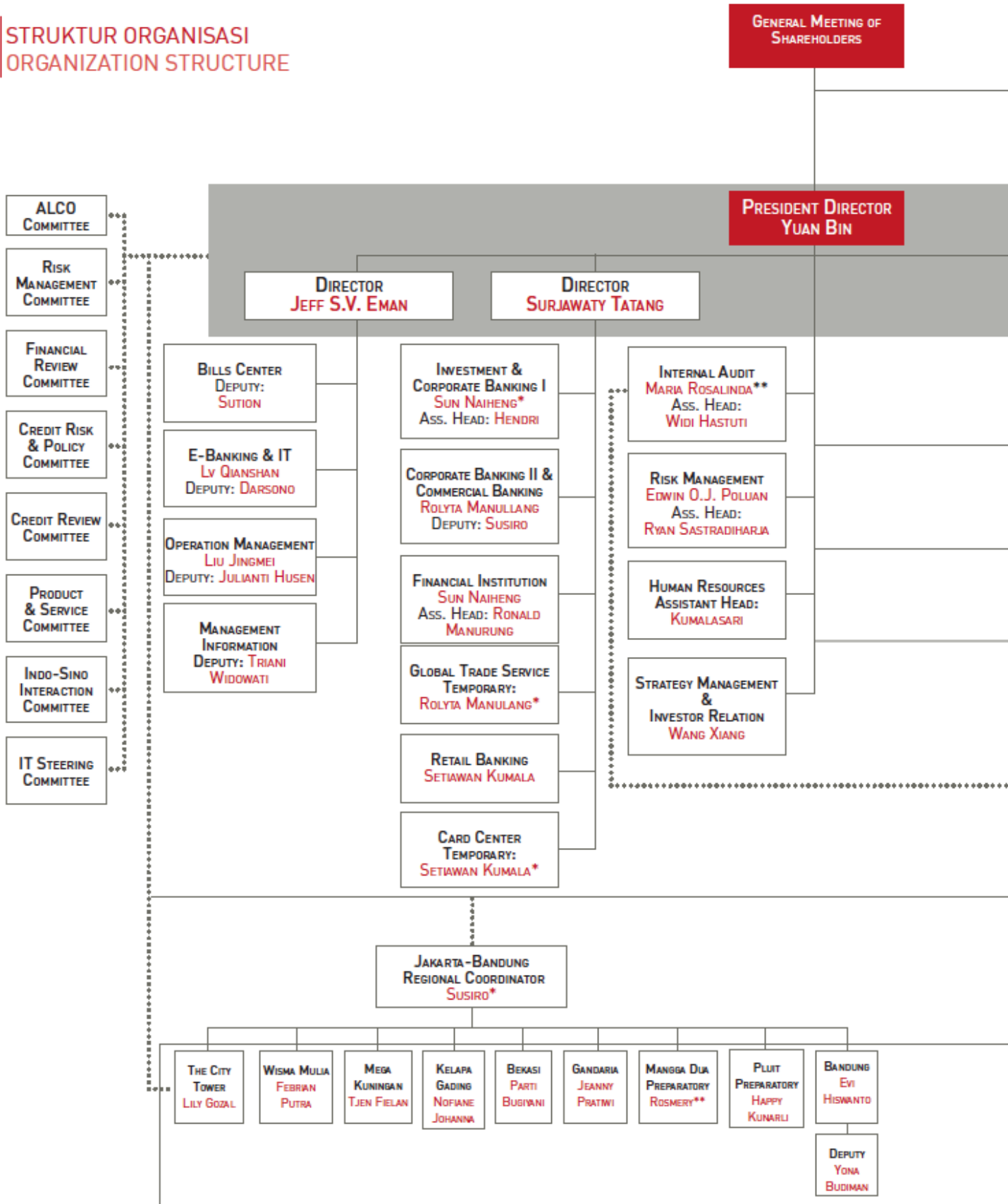

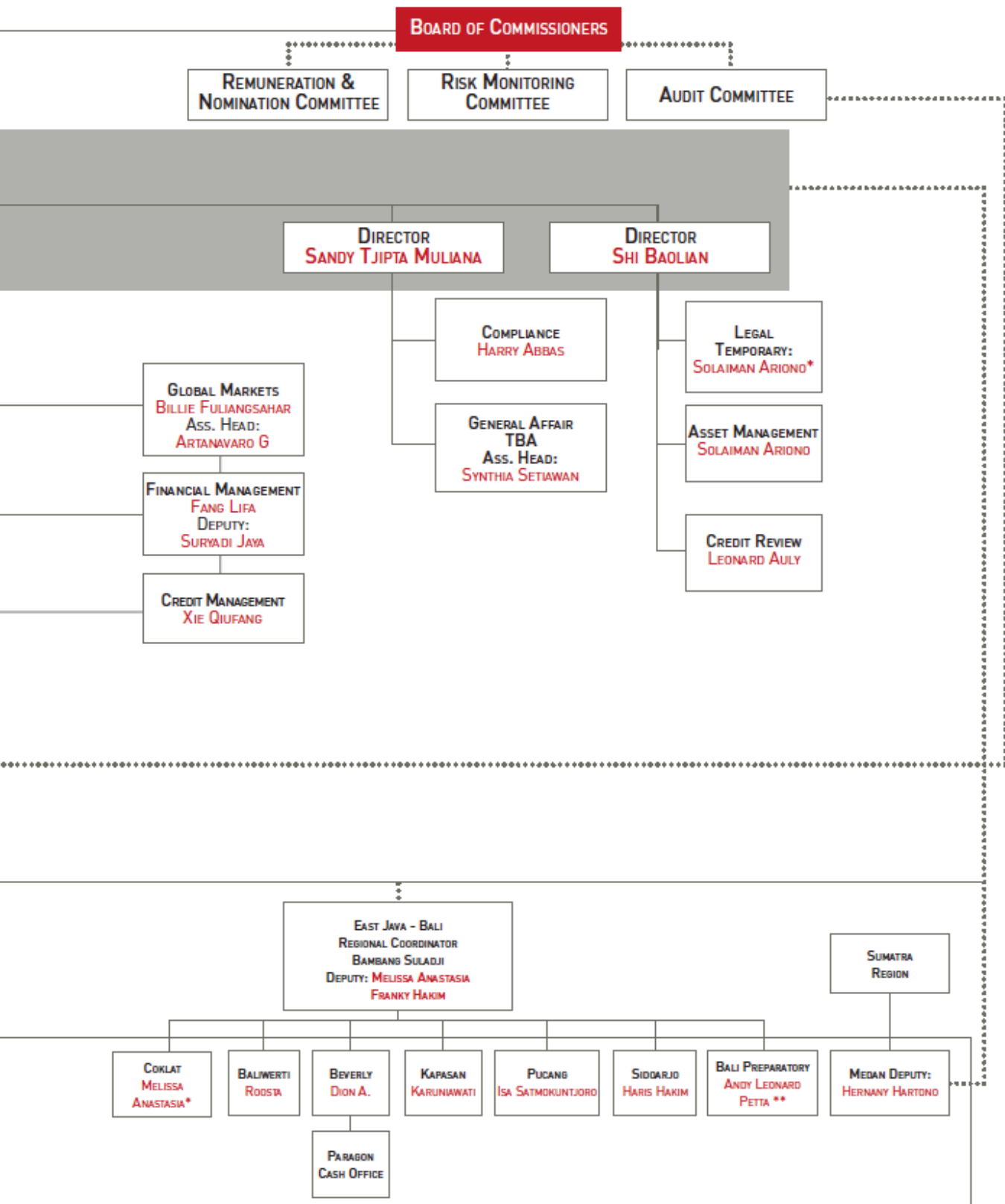
**STRUKTUR ORGANISASI

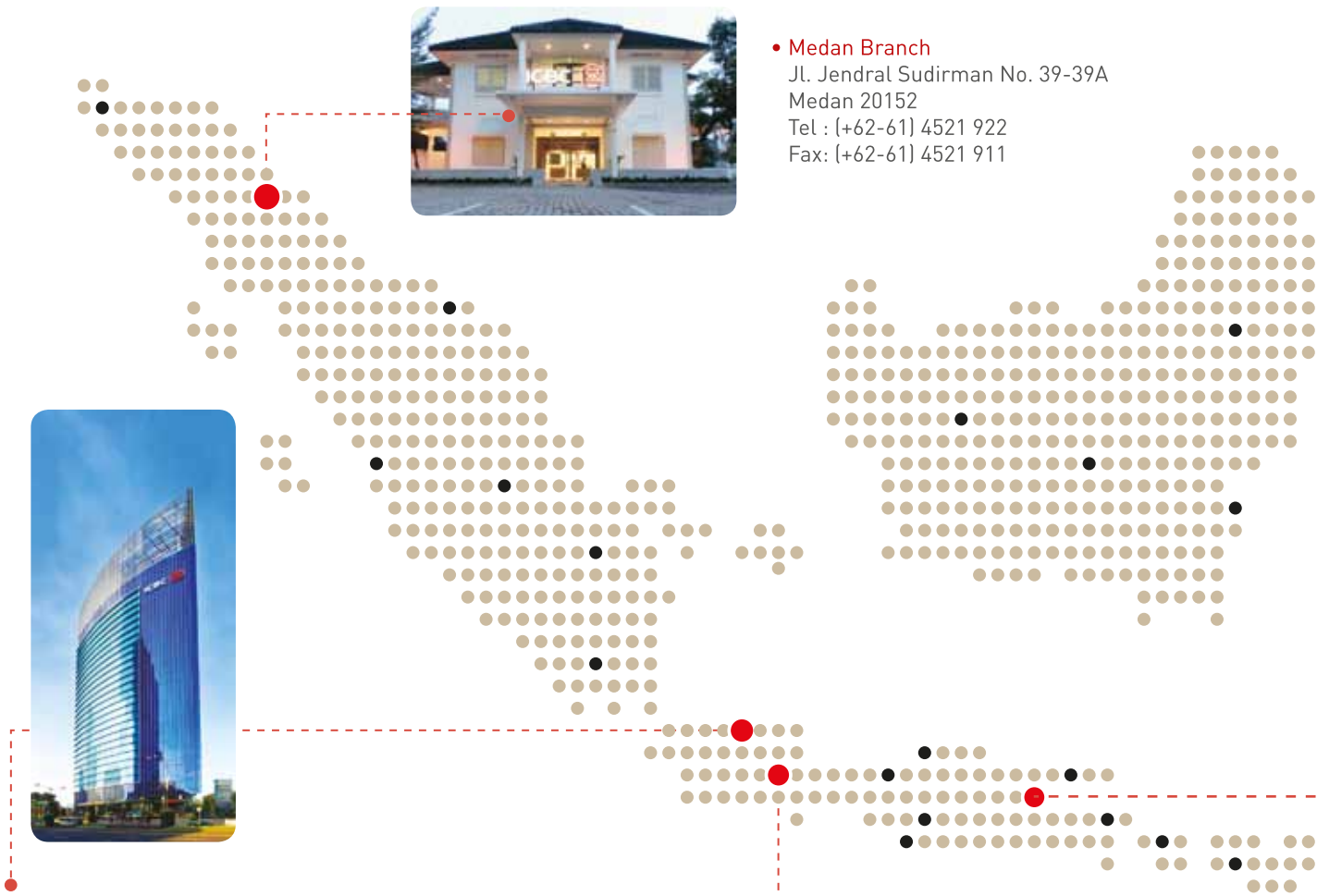

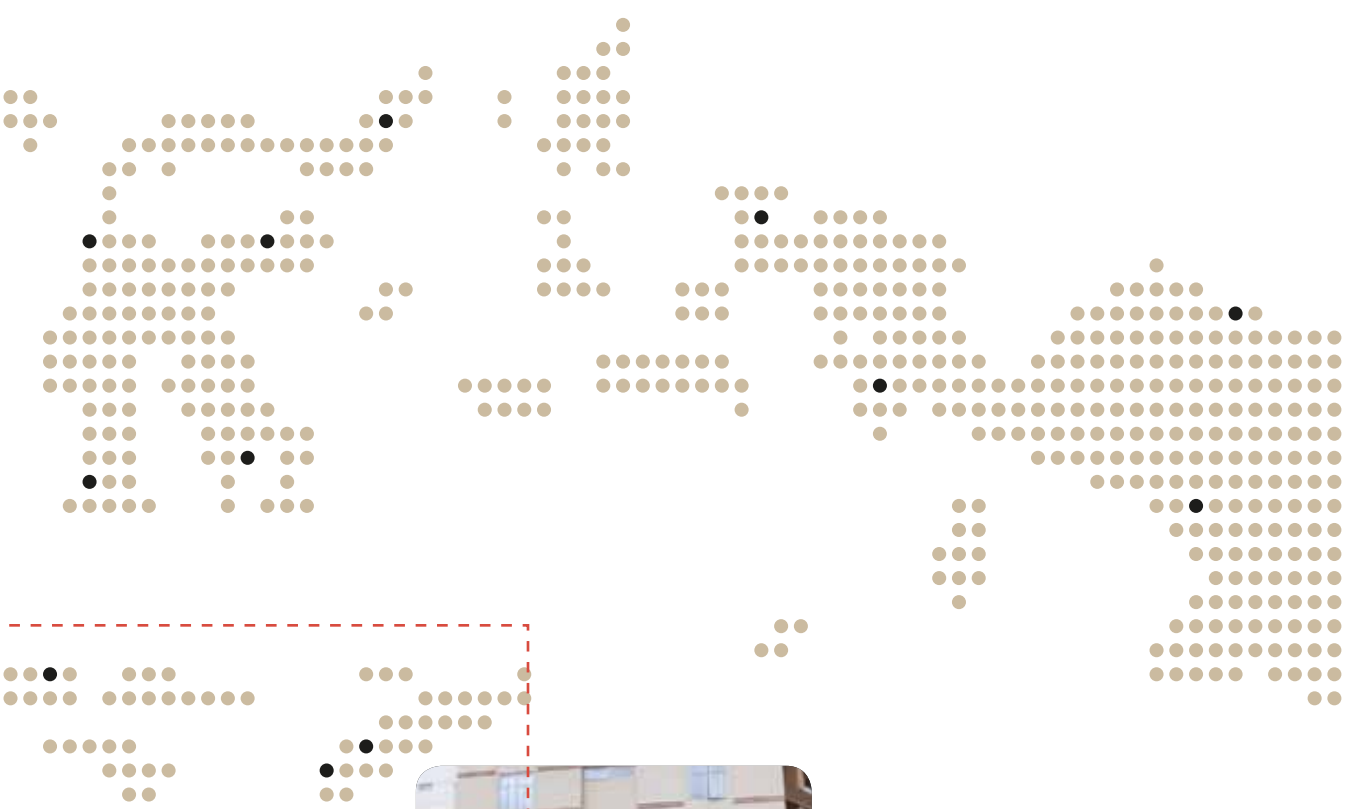
