ANNOUNCEMENT OF RESOLUTIONS OF THE BOARD OF DIRECTORS

1. Proposal on the Appointment of Mr. Wang Jingdong as Senior Executive Vice President of Industrial and Commercial Bank of China Limited

Voting result of this proposal: 15 valid votes, 15 voted in favour of this proposal, 0 voted against and 0 abstained from voting.

It was resolved at the Meeting that Mr. Wang Jingdong be appointed as Senior Executive Vice President of the Bank, subject to approval by the China Banking Regulatory Commission. Biography of Mr. Wang Jingdong is set out in the Appendix.

Opinion from independent non-executive directors on this proposal: Agreed.

2. Proposal on the Resolution Plan of the US Branches of the Bank

Voting result of this proposal: 15 valid votes, 15 voted in favour of this proposal, 0 voted against and 0 abstained from voting.

According to the requirements of relevant laws and regulations of the United States of America (the "**US**"), both US and foreign banks of a certain size shall formulate and submit to the US authorities the resolution plan, which will be renewed annually, to ensure prompt and orderly self-rescue, reorganization or disintegration so as to reduce the impact of financial crisis on the US financial system.

The resolution plan was considered and passed in the Meeting. The Meeting also authorized the President of the Bank to be in charge of the filing of the resolution plan and the annual renewal going forward.
