If correctly completed and lodged with the H Share Registrar of the Bank not less than 24 hours before the time fixed for holding the Extraordinary General Meeting or any adjournment thereof, the Second Proxy Form shall supersede the original proxy form issued by the Bank along with the Notice of the Extraordinary General Meeting on 10 October 2011.
