ANNOUNCEMENT OF THE RESOLUTION OF THE BOARD OF SUPERVISORS

A regular meeting of the board of supervisors (the “**Meeting**”) of Industrial and Commercial Bank of China Limited (the “**Bank**”) was held as a physical meeting and by way of telephone conference at the Bank’s head office on 30 October 2012. There were seven supervisors eligible for attending the Meeting and all of the seven supervisors attended the Meeting in person. The Meeting was convened in compliance with the relevant provisions of the laws, administrative rules and regulations and the Articles of Association of Industrial and Commercial Bank of China Limited.

Mr. Zhao Lin, Chairman of the board of supervisors, presided over the Meeting and the Proposal on the Third Quarterly Report of 2012 was considered and passed at the Meeting.

The board of supervisors of the Bank was of the opinion that the preparation and audit procedures in respect of the Third Quarterly Report of 2012 of the Bank complied with the laws, administrative regulations and supervisory requirements and the report reflected the actual situation of the Bank truthfully, accurately and completely.
